If permit is to cover unmarked company trucks, please attach a list to this form giving year and make of truck, VIN#, maximum weight, and registration#.

The holder of a permit shall be liable for any damage to highways or bridges per VSA Title 23, Sec 1400a (c) and is **required to furnish the municipality a valid Certificate of Insurance** in the following amounts: a minimum of \$100,000/\$300,000 Personal Injury Liability Coverage and \$100,000 Property Damage Coverage.

SPECIAL CONDITIONS FOR OVERWEIGHT VEHICLES

Permits are required annually for any vehicle having a Gross Vehicle Weight over the Legal Posted Road Limit.

Adopted pursuant to Vermont Statutes Annotated Title 23§1400 and 1400A.

No trucks over the legal posted road limit on the following bridges:

Rabbit Hollow RR Bridge (#55)	16,000 lbs. T.H. #57
Slaughter House Covered Bridge (CB64)	16,000 lbs. T.H. #14

Covered Bridges are historic structures. Please help to protect them.

All Covered Bridges have a ten-foot (10') height limit.

Other local bridges may not be sufficient for heavy loads.

Lighter limits apply during annual road posting in the spring or any other time the roads may become soft. Call before using the road.

An insurance certificate is required with the permit application. Applications will not be processed until the insurance certificate has been received.

There is no charge for a permit.
